3. MINUTES

3.1 Draft Minutes of the October 23, 2015 Salt Spring Island Watershed Protection Authority Regular Meeting

By general consent, the Salt Spring Island Watershed Protection Authority Minutes of October 23, 2015 were adopted.

4. BUSINESS ITEMS

4.1 Chair's Report

Chair Grams reported that he will be presenting "SSIWPA - A Year In Review" at the Open House event. He presented the new SSIWPA website and highlighted the new document library.

4.2 St. Mary Lake Water Quality Update – North Salt Spring Waterworks District

Jeff Thompson reported that recent rain has raised the level of St. Mary Lake to 40.29 metres, which is less than halfway to full capacity and the water quality is in good condition.

4.3 Coordinator's Report

Coordinator Cowan presented the Coordinator's Report for October 16, 2015 to November 20, 2015. She highlighted that she has started to action the action items in the SML IWMP; including a survey for Cusheon Lake Watershed and St. Mary Lake Watershed. The first survey information will be received in the first quarter of 2016 to enable SSIWPA to apply for grants for actions such as signage, riparian restoration and biodiversity management actions. There is an Islands Trust initiative within the Trust Programs Committee to be able to apply some of their resources to water conservation in terms of public education in 2016.

Lorrie Hunt reported the Salt Spring Island Water Council has been approved to receive the gaming grant and will provide funds to the 2016 Water Fair.

4.4 Technical Working Group Report

Don Hodgins presented Technical Working Group (TWG) progress and the following highlights were presented:

- SML monitoring:
 - P-runoff measurements have resumed, three rounds are complete and the first flush measured for TP and SRP, and flow rate;
 - Rainfall a sampler has been constructed, three rounds have been completed, TP and SRP. Recent research shows that the P levels are quite high, will have several samples by late December;
 - Trend analysis P and algal abundance, determine criteria for change direction. How much change to see if intervention results in a real reduction in P:
 - Lisa Rodgers has completed thesis and final estimates of P-runoff from MAPSHED are to be incorporated into the final report.

2016 Watershed Governance Capacity-building workshop - southern vancouver island region

In the winter of 2016, the POLIS Project on Ecological

Governance http://poliswaterproject.org has the opportunity coordinate a watershed governance capacity-building workshop in the Southern Vancouver Island region. The broad goal of the workshop is to increase the capacity of local decision-makers (including First Nations' and local/regional governments) and watershed groups (i.e., watershed boards, roundtables, and advisory groups) to effectively engage in watershed decision-making. - 4. Strengthen connections and learning between key groups and initiatives across the region including senior local government staff, First Nations, stewardship leaders, elected officials
